Copyright Transfer Form

To the *Turkish Red Crescent*,

Our *Manuscript* with a suitable title and authors has been uploaded on the ScholarOne *Manuscript* for evaluation for possible publication in your journal. This study has not been published, accepted for publication anywhere previously, or sent to another journal for evaluation.

In the event that the study is accepted for publication, the “Right to Process” regulated in Article 21; the “Right to Reproduce” regulated in Article 22; the “Right to Disseminate” regulated in Article 23; the “Right to Represent” regulated in Article 24, including digital transmission regulated in Article 25 of Law No. 5846 on Intellectual and Artistic Works (FSEK); “Broadcasting to Public by Tools for Signal, Sound, and/or Image Transmission,” including re-transmission, transmission to the public, and representation of power; the right to transmit to the public by providing access to the *Manuscript* at the place and time chosen; and other rights stated in this agreement pertaining to the *Manuscript* will be transferred exclusively to the *Publisher* without limitation in place, number, content, and time during the period of protection with the law in effect on the date this agreement is signed.

Additionally, the moral rights remain with the Authors (henceforth, *Corresponding Author*). However, the *Publisher* has the power to exercise the moral rights within the frame of the financial rights transferred to it.
